

ORDER

Pursuant to Art. 25, para. 4 of the Law on Administration and in connection with Order No. RD-01-549 / 30.09.2020 of the Minister of Health and in connection with Decision No. 673 of the Council of Ministers of 25 September 2020 on the extension of the term announced by Decision No. 325 of the Council of Ministers of May 14, 2020. epidemic emergency situation, extended by Decision No. 378 of the Council of Ministers of 12 June 2020, Decision No. 418 of the Council of Ministers of 25 June 2020, Decision No. 482 of the Council of Ministers of 15 July 2020, Decision No. 525 of the Council of Ministers Council of 30 July 2020 and Decision 609 of the Council of Ministers of August 28, 2020.

I. ORDER

1. As of October 1, 2020. until 30.11.2020:

According to items 1, 7 of Order RD-01-549 / 30.09.2020 of the Minister of Health, all collective and individual sports events of a training nature for all age groups indoors are held without audience . When holding outdoor sports competitions, an audience of up to 1,000 people per sector is allowed, with a seat occupancy of not more than 50%, accommodation of spectators in at least one seat and subject to a physical distance of 1.5 m. in indoor sports competitions, the public is allowed, when the spectators are accommodated in at least one seat and when observing a physical distance of 1.5 m, when the seats are occupied not more than 50%.

II. The activities under item I. shall be carried out under all anti-spice measures introduced by Order No. RD-01-548 / 30.09.2020 of the Minister of Health, in compliance with the instructions under item

III. under the following conditions:

1. It is obligatory the application of a protective face mask for single or multiple use or other means covering the nose and mouth (including towel, scarf, helmet, etc.) for employees, staff, coaches and officials in sports facilities and practice facilities of indoor sports, in dance halls, swimming pools and fitness centres and gyms. and training activities in sports facilities and sports fitness.
2. It is allowed, during competitive and training activities in sports sites and facilities for indoor sports practice, in dance halls, swimming pools and fitness centres and gyms, athletes and athletes not to put a protective face mask for single or multiple use or other means covering the nose and mouth (including towel, scarf, helmet, etc.).

III. In connection with item II. of Order No. RD-01-549 / 30.09.2020. of the Minister of Health I approve:

1. Instructions-Concept and guidelines for the resumption of the training and competition process according to Annex N 1
2. Instructions for application of anti-epidemic measures in fitness centres and gyms according to Annex N 2
3. Instructions for application of anti-epidemic measures of sports facilities and facilities according to Annex N 3

IV. I revoke Order RD-09-962 / 01.09.2020.

V. The order enters into force on October 1, 2020. VI. The order and instructions under item I to be published on the website of the Ministry of Youth and Sports. I assign control over the execution of the order to the Deputy Minister of Youth and Sports Stoyan Andonov.
